

Declaration of party membership

What this form is for

A member of a political party can complete this form and send it to their party to help establish or confirm the party's eligibility for registration in NSW.

How to use this form

- Only the party member may complete this form. It must not be altered or pre-filled.
- This form is sent to the party (**not to the NSW Electoral Commission**) when completed.
- The party member can check their details on the [electoral roll](#) to ensure accurate information is provided.

Privacy

The NSW Electoral Commission has obligations under privacy legislation, including about collecting, managing, and storing personal information. The personal information collected on this form or included in any other documentation, information or evidence you provide in connection with the form will be used by the NSW Electoral Commission to undertake its statutory and administrative functions relating to party registration, including to confirm the party's eligibility to be registered for NSW State and/or local government elections. We may also use it to update your contact details in our records, conduct inquiries to verify the information that you have provided to us, send you relevant notifications or reminders (including via sms or email), provide information about your statutory obligations or invite you to participate in relevant surveys or information seminars. Your provision of the information in this form is voluntary. Not supplying all the information requested may delay or prevent the party from relying on you in support of its eligibility for registration. The information collected is held by the NSW Electoral Commission and is accessible by relevant staff and its contractors. Please note that information contained in this form may be included in the Register of Parties and/or Local Government Register of Political Parties and may be viewed as part of a public inspection of a registered political party's information. If a silent elector provides their address, it will be redacted before the form is made available for inspection. We will disclose your personal information to other persons or entities if we are lawfully authorised or required to, for example, to other relevant investigative agencies for law enforcement purposes. You can find additional information in the NSW Electoral Commission's [Privacy Management Plan](#) concerning access to and correction of your personal information.

Please note that this form may be viewed as part of a public inspection of a registered political party's information. If a silent elector provides their address it will be redacted before the form is made available for inspection.
